3. Distance will be calculated from KV Barkakana and back/the pickng point/dropping point.
4. The bidder shall quote for items in the format of quotation attached. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
5. All duties, taxes and other levies payable by the bidder, shall be included in the total amount. The rate quoted should be inclusive of all tour/permit charges/tax/parking etc.
6. The quotation shall remain valid for a period of One Year after the deadline specified for submission of quotation. Likely to extend for next year also.
